**Monthly billing plans are subject to price adjustments during the year if membership costs increase.

Membership Benefits Include:

- Unlimited Greens Fees.
- Daily Cart Fee per rider w/ one cart per 2 players; 18 Holes \$21.00 ea., 9 Holes \$13.00 ea.
- Walking 18 holes at no additional cost.
- Practice Range \$ 5.00 per bucket regardless of size. Practice Balls to be used by the member ONLY. No additional person(s) is permitted to use balls purchased under the member's plan.
- Discounted guest rates for guests playing with a member, up to 3 per day. The member must accompany guest at time of guest's check in to be entitled to receive discount, \$5.00 for 18-hole round or \$3.00 for 9-hole round, and is for riding only. (No discount for walking)
- 10% discount on all in-stock retail merchandise (excluding golf balls).

Practice Range Membership:

- Practice balls are for use by the range member <u>only</u>. No additional person(s) is allowed use of practice balls shared and provided by the range member. Membership privileges subject to termination for violation.
- Tokens available up until 10 minutes before the golf shop closes daily.

Member Annual Golf Cart Rental Agreement

This is a one-time acknowledgement of the golf cart responsibilities each time you play:

- 1. The member(s) shall abide by all rules and regulations governing the use of the golf cart and shall always operate the golf cart in a safe manner.
- 2. The rental age is 16 years or older with valid driver's license.
- 3. The member(s) acknowledges receipt of the golf cart for play and was received in good condition and is to be returned in the same.
- 4. The member(s) shall reimburse Henderson Golf Club upon demand for all costs and expenses for the loss of or any damage to the golf cart or property while it is rented.
- 5. The member(s) shall indemnify and hold Henderson Golf Club harmless from any and all liability, including bodily injury and property damage arising out of the use or operation of this golf cart by golfer, or anyone using or operating the cart with the renter's express or implied consent.
- 6. Golf cart to be used on golf course property only.
- 7. Maximum of 2 individuals on cart at any time.
- 8. This agreement expires on membership expiration date.
